High risk work groups for exposure to asbestos in New Mexico include US Navy Veterans, power plant workers, oil refinery workers, civilian employees of the Defense Department, manufacturing, or industrial workers, plumbers, electricians, auto mechanics, machinists, miners, or construction workers. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.
