

The FLNG market will continue to register strong growth over the coming decade | Floating LNG 2017

Floating LNG will assess LNG market dynamics and economics, technology innovations, case studies plus project finance and risks associated within this industry.

LONDON, ENGLAND, UNITED KINGDOM, October 17, 2016 /EINPresswire.com/ -- The floating liquefied natural gas (FLNG) market is developing quickly, with the first LNG FPSOs scheduled for delivery in 2016 and the number of countries ordering FSRUs expanding. Though the impact of lower oil prices and an oversupplied LNG market are creating challenges to project economics, the FLNG market will continue to register strong growth over the coming decade. The FLNG market will reach a capex of \$7.17bn in 2016, with the liquefaction (LNG FPSO) part of the market worth \$5.06bn, and the regasification (FSRU) part of the market seeing capex of \$2.11bn.
