The State agency that is supposed to ensure the protection of the disabled and justice is doing the exact opposite and protecting those harming people with disabilities. State documents obtained through Jonathan's Law, named after Jonathan Carey who was killed by his New York State caregivers, reveal no law enforcement involvement. People at the NYS Justice Center were involved in covering up these heinous crimes and tragically this case is the tip of the iceberg of what is going on behind closed doors. Thousands of criminal reports are reported every month ( a staggering 7,800 on average) to the Justice Center abuse hotline for the disabled and hardly any are reported to local police or County elected District Attorney's who have the jurisdictional authority criminally investigate and prosecute these crimes.
