

## EPICAN Gets Jamaica's First License To Commercially Cultivate Medical Marijuana

Conditional License for 3 other categories (Processing, Retail & Research And Development). EPICAN anticipates the final approval and issuance of those license in the near future. Once received EPICAN will implement its vertical integrated operations at its 5000 sqft Processing facility, where

EPICAN has submitted products to Jamaica's Ministry Of Health for registration and awaits approval from the Medicinal Cannabis Unit MCU).
