<u>superior/</u>. Mr. Kiyonaga was promoted instead of fired, why? Are there major skeletons in the closet?

Numerous calls for the firing of Jay Kiyonaga went directly to the Governor and his Deputy Secretary of Health, Paul Francis, by Michael Carey, the founder of the Jonathan Carey Foundation, for many months before these sexual harassment allegations surfaced publicly, they all were ignored. Instead of Jay Kiyonaga being fired for allegations of covering -up sex crimes and deaths of people with disabilities, Jay Kiyonaga was left in his position for many months and then secretly promoted by Governor Cuomo.
