

High-risk work groups for exposure to asbestos in Texas include Veterans of the US Navy, power plant workers, oil refinery workers, oil rig workers, chemical plant workers, factory workers, plumbers, electricians, auto mechanics, machinists, and construction workers. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.

The states indicated with the highest incidence of mesothelioma include Maine, Massachusetts,



Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon. However, because Texas is one of the nation's largest energy producing states mesothelioma does happen to very good people in Texas.
