Do the math - multiply 1,300 times 33 to get the approximate real numbers which statistically would be 42,900 in a system of 126,000 developmentally disabled children and adults. Another way to look at these horror and astronomical atrocities is that approximately one third of the people with developmental disabilities will be sexually assaulted once every year.

Governor Cuomo knows about these atrocities, he has protected most of the criminals involved and he has taken no significant actions to stop or prevent any of these sex crimes or criminal cover-ups. Governor Cuomo must be investigated and criminally charged as soon as possible.

No longer can 911 and local police be bypassed. 911 call systems must be immediately called by all mandated reporters regarding all sexual abuse and obviously all other crimes and medical emergencies. Donate to support this vital Civil Rights Movement for the disabled and their families, but also for our country and the world, the maltreatment and unequal treatment of the disabled is an international societal problem that must be addressed now.
