The primary reason, tragically, is because both Governor Cuomo and Cardinal Dolan look the other way and refuse to listen, refuse to lead and refuse to take numerous vital emergency actions to protect people with disabilities. It is a travesty and a shameful disgrace that all of these horrors continue to date in 2017, when most of it could have been stopped long ago. Just like most of the pedophile Catholic priests could have been stopped, but instead they were shuffled by Catholic Church leaders from parish to parish to sexually victimize and rape other innocent children. I urge you to watch this less than 3

You must also understand that the same game plan or scheme to jockey around pedophile priests

from parish to parish to protect the institution and not the victims of the <u>pedophiles</u> is going on literally all of the time within New York State's mental health care system. Some symbolism's will be used so that you can easily understand the players and how such levels of atrocities can continue, but first, you must understand the scope of sexual assaults and rapes occurring. One glimpse into just one of six of New York State's mental health agencies, made up of both State and private facilities and group homes, called the Office of People with Developmental Disabilities (OPWDD) 1,300 reported sexual assaults on average every year. As if this number was not bad enough, it is only the tip of the iceberg; according to this well known and respected study called "Prevalence of Violence" which states that only 3% of these sexual assaults will ever be reported. So to get a clearer, closer and more accurate number, multiply the 1,300 times 33 and the real numbers are close to 43,000 sexual assaults or rapes, every year http://www.mass.gov/dppc/abuse-recognize/prevalence-of-violence.html.

There is an epidemic and culture of sexual abuse, rape and cover-ups within Governor Cuomo's OPWDD system and remember there are 5 other mental health agencies as well. Now to the symbolisms that represent the players involved in this corruption; the top dog or big dog allowing all of this and protecting it from the inside is Governor Andrew Cuomo. The top dog from the outside is Cardinal Timothy Dolan. The pedophiles, sexual predators and rapists posing as caregivers or wolves in sheep's clothing are the little dogs and their sick crimes that are being protected by the top dogs. Hopefully, you fully grasp and get the picture and the meaning behind what is being spoken. Obviously, if the top dogs, Governor Cuomo and Cardinal Dolan, simply did their jobs and did not protect most of the pedophiles, sexual predators and rapists, but instead the victims and simply moved to stop and prevent the rampant sexual abuse, the system would have been changed years ago. The horrors, the severe damages, the trauma, the pain, the maltreatment, the violation of one's very soul, these atrocities, the undue suffering have only continued because of the gross negligence and blatant disregard for the safety, health, rights and lives of 1,000,000 New Yorkers with disabilities by both Governor Andrew Cuomo and Cardinal Timothy Dolan.

Thousands of reported sex crimes committed against the disabled are never reported to local police or District Attorney's and are disappearing within the system that former Attorney General Cuomo and now Governor Cuomo has protected with a vengeance for over a decade. Governor Cuomo has tried to portray that he has taken actions to protect the disabled since the award winning New York Times "Abused and Used" investigative reporting series

<u>http://www.nytimes.com/interactive/nyregion/abused-and-used-series-page.html</u> which Michael Carey convinced the Times to do, but nothing could be further from the truth. Governor Cuomo took no decisive actions to stop or prevent the rampant sexual abuse, rapes or cover-ups.

Governor Cuomo has ignored all of Michael Carey's calls for actions to stop these crimes and even the New York Times Editorial Boards call for repentance. "Two-and-a-half years ago, The Times reported horrifying abuse of people with developmental disabilities or mental illnesses by state employees, who were rarely punished for it. Gov. Andrew Cuomo promised action. But too little appears to have changed."

"There is much the governor could do. He could require surveillance cameras in these facilities, just as prisons have them. He could make sure that the police get more involved."

There are cameras everywhere literally to guard and protect store items and politicians, but no cameras to protect our most vulnerable disabled from being raped? Governor Cuomo has ensured that there are no cameras to deter these crimes or to catch and prosecute the pedophiles, sexual predators and rapists of people with disabilities in his agencies. Michael Carey met with Governor Cuomo for an extensive meeting on May 7, 2012 in which Michael Carey insisted on cameras and immediate 911 reporting, Governor Cuomo blew of both vital reforms critical to ensure the protection and rights of 1,000,000 New Yorkers with disabilities, even to go as far as saying that he wanted cameras, but the unions didn't want them.

Here are just some of the reasons why New York State's system still remains rampant with sexual abuse and rapes and likened to an animal house under Governor Andrew Cuomo;

- Incompetent and completely insufficient background checks that allow sexual predators, pedophiles and rapists, even those with known histories to be easily hired
- Purposeful under-staffing of direct care workers and supervisors, especially on evening and night shifts when most of these heinous sex crimes occur
- The absence of surveillance cameras in all facilities, group homes and transport vehicles to deter these crimes from happening and to catch these sexual predators
- Untrained and improperly vetted male direct caregivers allowed to bath women and little children alone
- Untrained and improperly vetted male direct caregivers allowed to transport women and little children alone in vans with darkened windows with no surveillance cameras
- Untrained and improperly vetted male direct caregivers allowed to do female personal hygiene, Peri-care, on women and young girls alone
- Incompetent management personnel that are grossly over-paid that are willing to do anything to keep their lucrative jobs. Most management staff compromise their own conscience and commit even greater crimes to protect themselves from losing their job and in doing so protect dangerous sexual predators and rapists of vulnerable people under their care
- Hundreds of thousands of State and private caregivers are trained to report sex crimes internal to

Governor Cuomo's abuse hotline for the disabled; instead of to report these crimes to 911 so local police and emergency medical personnel cannot respond. These practices are without question – discrimination in civil rights per Section 11 of the NYS Constitution under Article 1 of the Bill of Rights. Also, the 14th Amendment of the US Constitution is being regularly violated by denying upwards of 1,000,000 New Yorkers with disabilities equal protection of laws when they are victims of sex crimes. Keeping most of these sex crimes from local police, from proper criminal investigations and from County elected District Attorney's is not only unconstitutional, but illegal- it is Obstruction of Justice.

• Keeping evidence of sex crimes from local authorities and falsifying internal reports at Cuomo's abuse hotline wrongfully titled the Justice Center and within all mental health agencies.

• By protecting most sexual predators internally, they are not being placed on the sexual abuse registry. These despicable actions obviously also grossly endanger children in the general public and possibly in your community.

Most sex crimes, as well as many other crimes and deaths, are easily covered-up internally because they are being directed to be called to Governor Cuomo's internal abuse hotline, instead of to 911, where they must go. No longer can 911 call systems, local police, county elected District Attorney's and local courts be bypassed. 911 call systems must be immediately called by all mandated reporters regarding all sexual assaults and rapes, as well as obviously all other assault crimes, medical emergencies and deaths. Currently, under Governor Cuomo's directive, almost all sex assault and rapes of people with disabilities which are obviously crimes disappear internally, they are covered-up. This evil and these gross injustices must be stopped and the people involved in the greater crimes and criminal conspiracy to protecting sexual predators, pedophiles and rapists must be held fully accountable.
