


## Growth in Global Commercial Services Market Is 6.5% A Year

LONDON, GREATER LONDON, UK, December 7, 2017 /EINPresswire.com/ -- Growth in the global market for commercial services is speeding up, according to research by The Business Research Company. Increasing at 5.25% a year to 2016, it has accelerated to 6.5%, a rate that is forecast to continue to 2020. In that year the market will be worth \$5339 billion.

Commercial services is the largest segment of the general services market, which also includes real estate, leasing, civic and personal services but not professional or social services. The segment covers outsourced provision of office administration, employment-related



services, travel arrangements, waste management, facilities support, business support, automotive repair, repair and maintenance of agricultural, heavy and industrial machinery and equipment, investigation and security services and buildings-related services. The main clients for these services are businesses and organizations.

The four biggest segments within commercial services are employment services, waste management and remediation, travel arrangement and reservation, and office administration services. Together these were worth \$1764.3 billion in 2016, though they only make up under half of this diverse group of markets. Office administration services, which include billing and record keeping, financial planning, personnel, physical distribution and logistics is the fastest-growing segment, at 9.3% year on year, a rate which has accelerated from 5.7% before 2016. The trend to outsource and offshore these non-core functions to allow focus on the key areas of the business continues to support the office administration services segment.

North America and Western Europe are the largest markets for commercial services, worth over 60% of the global total between them. Growth, however, is another matter. At 11% year on year, South America's is the fastest-growing market, while Asia Pacific, which will put on \$203 billion of annual sales between 2016 and 2020, represents a significant challenge to developed markets growing at only 5% and 3.5% respectively.
