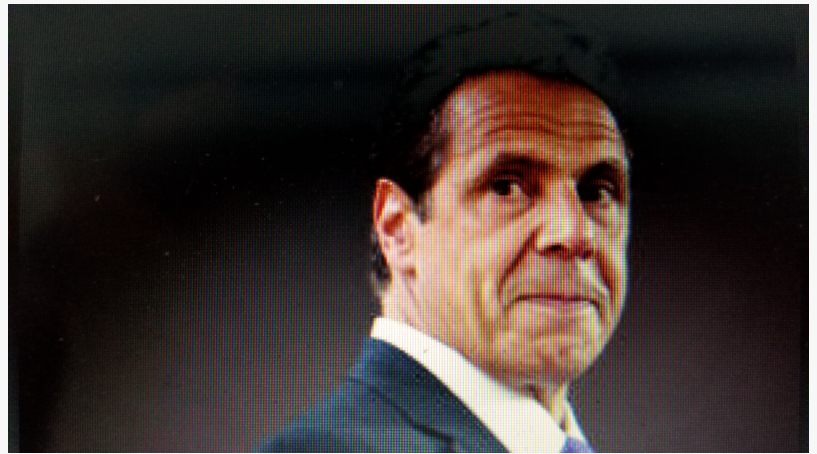


Cuomo Fails to Protect Women & Children from Sexual Predators
