


High-risk work groups for exposure to asbestos in West Virginia include US Navy Veterans, power plant workers, shipyard workers, oil refinery workers, steel mill workers, coal miners, manufacturing, or industrial workers, plumbers, electricians, auto mechanics, machinists, miners, or construction



workers. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.
